Refund Rules:

If a student chooses to withdraw from the program of study in which he / she is enrolled, the institution shall follow the following five-tier system for the refund of fees* remitted by the student.

| Sr. No. | Percentage of Refund of Aggregate fees* | Point of time when notice of withdrawal of admission is served to HEI |
|---------|--|---|
| 1 | 100% | 15 days or more before the formally-notified last date of admission (on or before 10th August 2020) |
| 2 | 90% | Less than 15 days before the formally-notified last date of admission. (i.e. from 11th August 2020 to 26th August 2020) |
| 3 | 80% | 15 days or less after the formally-notified last date of admission (i.e from 27th August to 10th September 2020) |
| 4 | 50% | 30 days or less, but more than 15 days, after formally-notified last date of admission (i.e 11th September 2020 to 25th September 2020) |
| 5 | 0% | More than 30 days after formally-notified last date of admission (i.e from 26th September 2020 onwards) |

In case of (1) in the table above, the HEI concerned shall deduct an amount not more than 5% of the fees paid by the student, subject to a maximum of Rs. 5,000/- as processing charges from the refundable amount.
