**Refund Rules:**

The Schedule of refund of fees will be as follows. If a student chooses to withdraw from the program of study in which he / she is enrolled, the institution concerned shall follow the following five-tier system for the refund of fees remitted by the student.

| Sr. No. | Percentage of Refund of Aggregate fees | Point of time when notice of withdrawal of admission is served to HEI                  |
|---------|--|--|
| (1)     | <b>100%</b>                            | 15 days or more before the formally-notified last date of admission                    |
| (2)     | <b>90%</b>                             | Less than 15 days before the formally-notified last date of admission.                 |
| (3)     | <b>80%</b>                             | 15 days or less after the formally-notified last date of admission                     |
| (4)     | <b>50%</b>                             | 30 days or less, but more than 15 days, after formally-notified last date of admission |
| (5)     | <b>00%</b>                             | More than 30 days after formally-notified last date of admission                       |

In case of (1) in the table above, the deduction will be 5% of the fees paid as processing charges from the refundable amount, subject to a maximum of Rs 5,000/-.
